CAD IT Group is highly present in Italy with its own branches throughout the national territory.

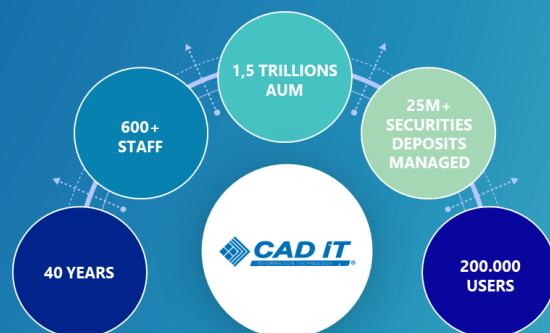
It also boasts considerable presence on the international market with customers in Switzerland, Germany, the United Kingdom, the Czech Republic, Spain, Portugal and Austria.
